Storage Cool, dry, frost-free and close lid tightly after use. Shelf life: 36 months. Protect from

direct sunlight. Always store in an upright position.

## Application Apply once on the affected areas with a suitable spraying device (without base metals

such as brass or copper etc.). Leave on for at least 60 minutes. Remove deactivated mould or rinse with water. To avoid fast new infestation it is recommendable to spray

again after it has dried.

## Safety advice Do not inhale aerosol.

Mould can be harmful, therefore the following precautions are absolutely necessary (also

on smaller areas):

Wear dust mask (e.g. P3) to protect against mould and their spores in the air.

Protective gloves to avoid skin contact.

Tight clothing.

# Additional information

Do not store in metal containers.

With sensitive materials, a test application on an inconspicuous place is recommended in

order to avoid e.g. unwanted color reactions on textiles.

In case of large-scale mould infestation and/or suspicion of hidden mould, please contact

an expert e.g. building biologist or specialised company for mould remediation.
